**OC1. CONDUCT OFFICIAL CANVASS BY THE CITY COUNCIL OF THE ELECTION RETURNS FOR THE CITY OF CLEBURNE GENERAL ELECTION HELD ON NOVEMBER 3, 2020.**

**SUMMARY:** This meeting of the governing body shall serve as the official canvass of votes for the City of Cleburne's General Election held November 3, 2020. On July 14, 2020, the City Council authorized an Election Services Agreement with Johnson County for conducting said election. The Elections Administrator (County EA) has provided the finalized tally that includes votes cast during early voting, election day and ballot by mail.

In accordance with Chapter 67 of the Texas Election Code, two members of the City Council will serve as the Canvassing Authority and are responsible for reviewing the election records as provided by the County EA no later than the 14<sup>th</sup> day after election day. The appointed Canvassing Authority will adjourn to the Conference Room for their review and report back to the Council with their determination.
