The Cleburne City Council invite citizens to consider active participation in their city government by serving on a board or commission. It is a unique opportunity to be involved in decisions that help shape the future of Cleburne.

Applications are accepted year-round. Board appointments are made in June and December, and are two-year terms, except where noted. Applicants must be a registered voter, be willing to attend regular scheduled meetings, and most positions require residency within the City of Cleburne. Meetings are open to the public.

4B ECONOMIC DEVELOPMENT CORPORATION

7 members

Meetings: 3rd Thursday at 5pm or as needed. City Hall, 10 N Robinson St

Develops, implements, provides, and finances projects under Section 4B of the Development Corporation Act.

AIRPORT ADVISORY BOARD

5 members

Meetings: 2nd Monday every other month at Noon. Airport Terminal Building, 1650 Airport Dr

Makes recommendations on the planning, growth, and operations at the Cleburne Regional Airport.



ANIMAL SHELTER ADVISORY BOARD

7 members

Meetings: Minimum three per year at 1:30pm. Booker T Washington Recreation Center, 100 Mansfield Rd

Assists the City in complying with requirements of State laws regulating Animal Shelter operations.



BUILDING AND STANDARDS COMMISSION

5 members + 2 alternates

Meetings: 3rd Wednesday at 9:00am. City Hall, 10 N Robinson St

Responsible for preservation of public safety relating to proper materials and methods used for building construction, fire safety or improvements of buildings and deteriorated buildings. This is a quasi-judicial board, which has the authority under state law to authorize condemnation of hazardous properties in the City.

CEMETERY ADVISORY BOARD

5 members

Meetings: Quarterly or as needed at Noon. Cemetery Office, 405 Watters St

Makes recommendations on operations and offers support to the Cemetery Department.

CIVIL SERVICE COMMISSION

3 members, 3 yr terms

Meetings: 3rd Tuesday at 1pm, or as needed. City Hall, 10 N Robinson St

Investigates and reports all matters relating to enforcement and effect of Chapter 143, Local Government Code, and any rules adopted under this Chapter. This is a quasi-judicial board of appeals for Police and Fire Departments.



LIBRARY ADVISORY BOARD

9 members

Meetings: 1st Monday at 6:00pm. Cleburne Public Library, 302 W Henderson St

Makes recommendations on operations of the Library and shall execute the rules and regulations pertaining thereto.

MUSEUM ADVISORY BOARD

9 members

Meetings: 3rd Tuesday at 5:00pm. Smith History Center, 200 N Main St

Makes recommendations and provides support for the city museums and promotes preservation of the museum building and other historic properties.



PARKS AND RECREATION ADVISORY BOARD

7 members

Meetings: 1st Monday at Noon. Municipal Services Building, 418 W Henderson St

Recommends plans for future development of City Parks and other matters regarding Parks and Recreation.

PLANNING AND ZONING COMMISSION

7 members

Meetings: 2nd and 4th Mondays at 6:30pm. City Hall, 10 N Robinson St

Holds public hearings on zoning matters and makes recommendations on development in Cleburne.



TAX INCREMENT FINANCING DISTRICT #2 (DOWNTOWN)

5 members

Meetings: As needed at Noon. City Hall, 10 N Robinson St

Holds meetings concerning the project and finance plan for the area encompassed by the TIF #2 Downtown Cleburne area. The five (5) member board is comprised of three City appointed representatives and two County appointed representatives.

ZONING BOARD OF ADJUSTMENT

5 members + 4 alternates

Meetings: 3rd Tuesday as needed at 5:00pm. City Hall, 10 N Robinson St

This is a quasi-judicial board of appeals, which is authorized by state law and city code to hear and decide appeals of citizens regarding zoning regulations of the City of Cleburne.
