

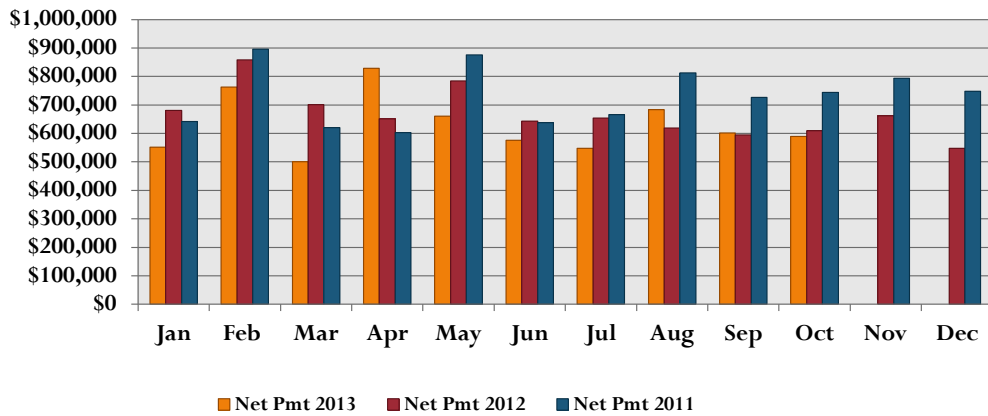

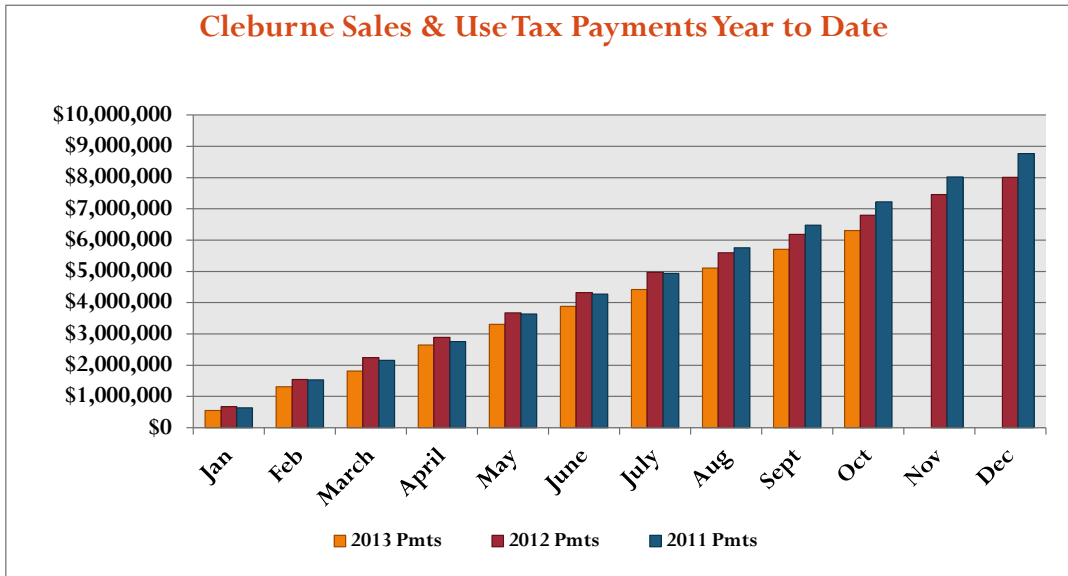
City Sales & Use Net Tax Payment Per Period 2011 thru 2013

 from the State Per Month Comparison



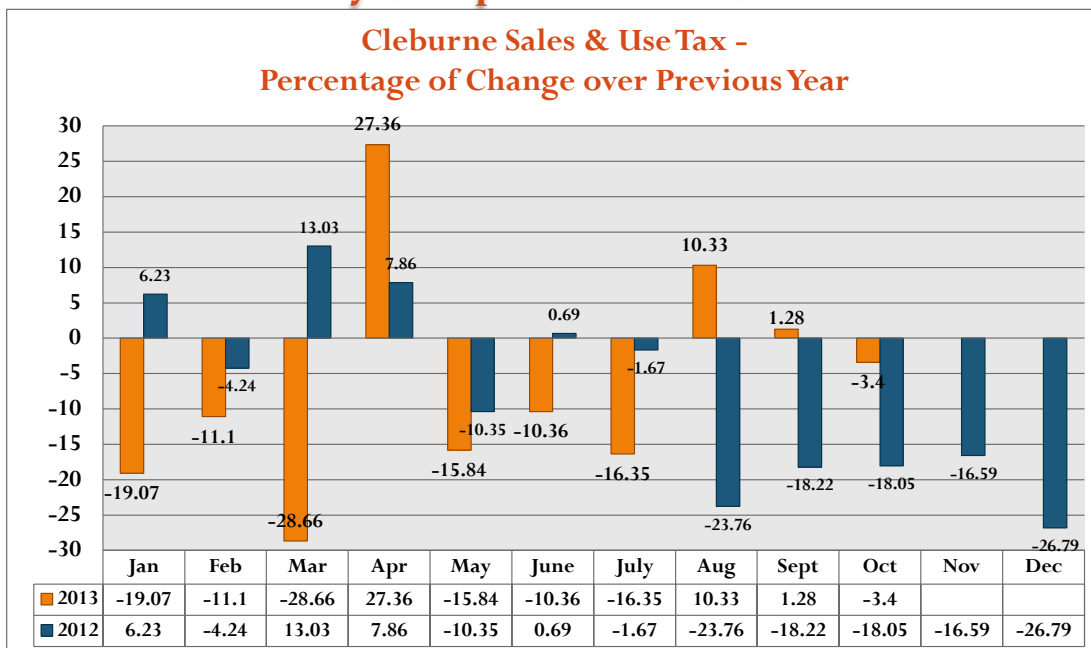

Cleburne Sales & Use Net Tax Payment YTD



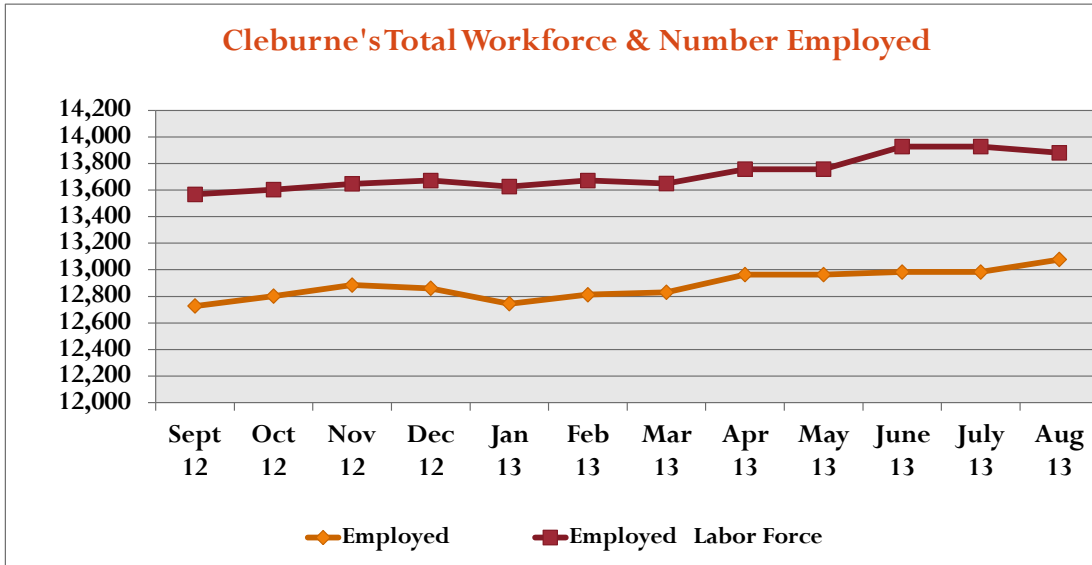

Cleburne Sales & Use Tax Monthly Comparison to Previous Year



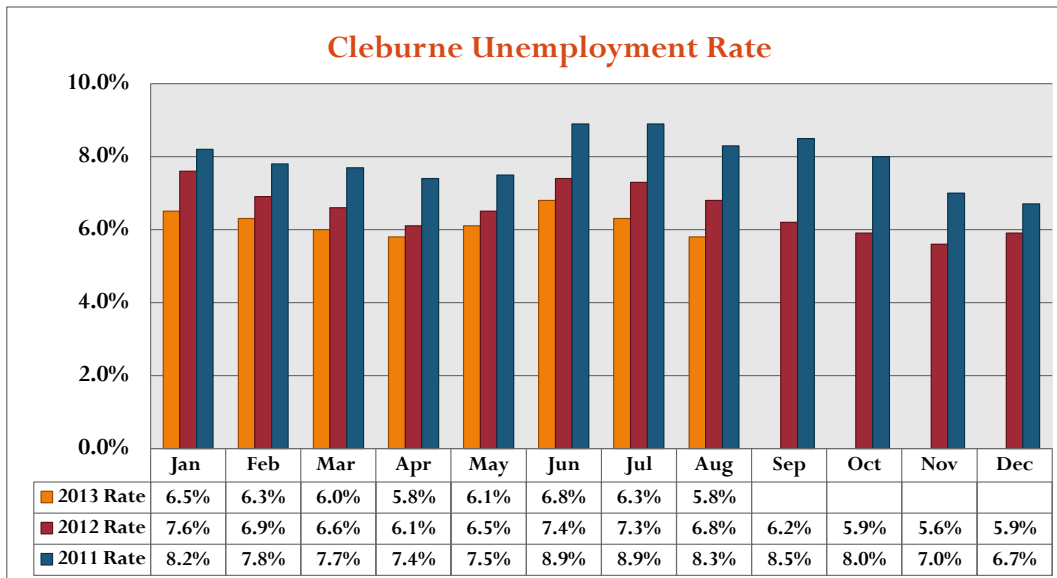

Cleburne's Total Workforce & Number Employed 12 Month Unemployment Comparison



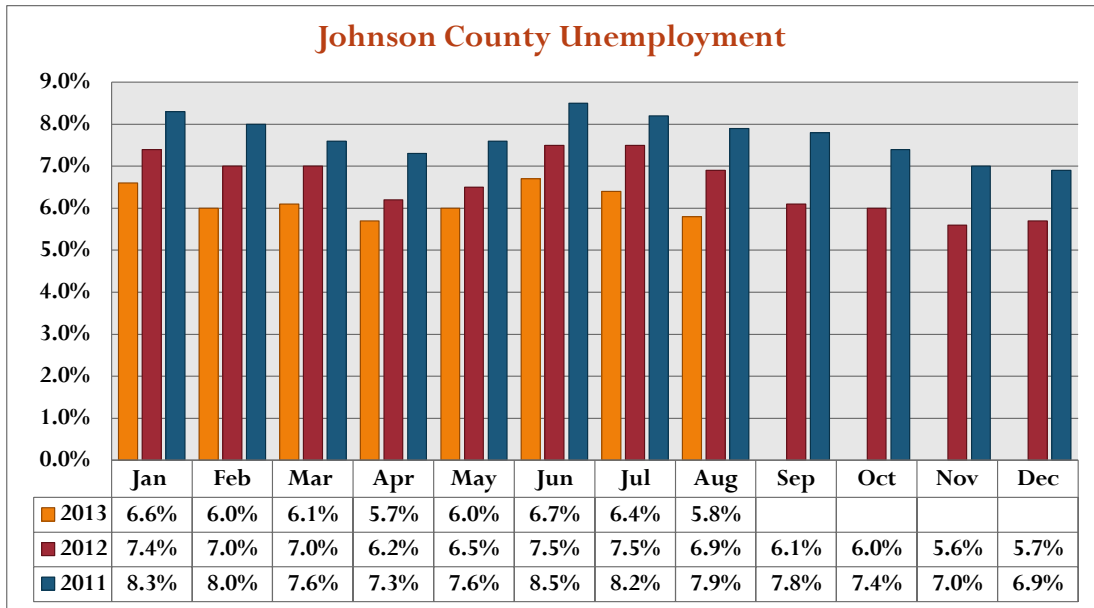

Cleburne Unemployment Rate Comparison 2011 thru 2013



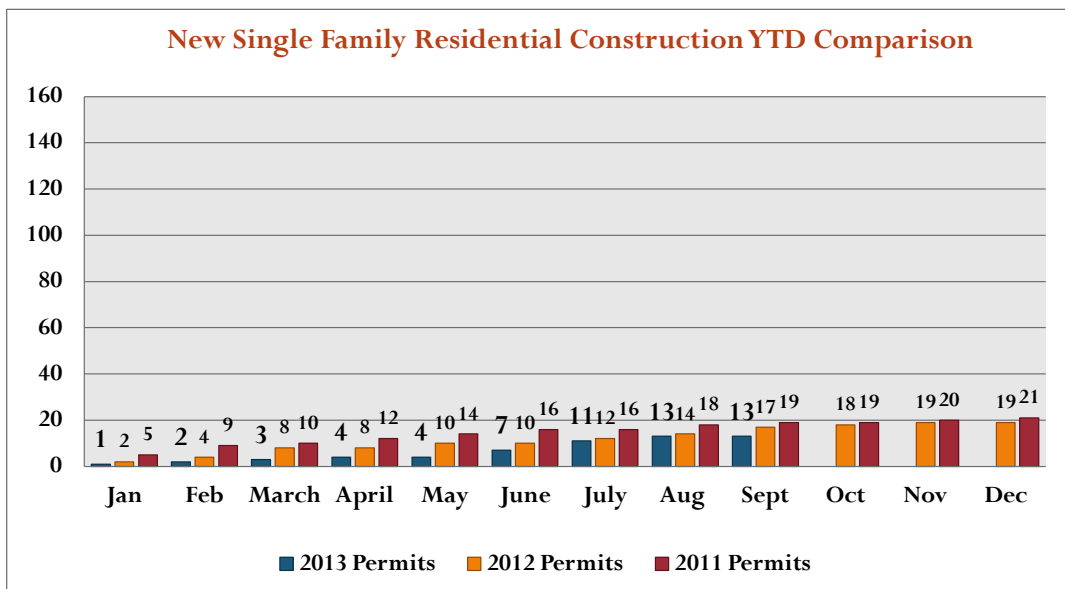

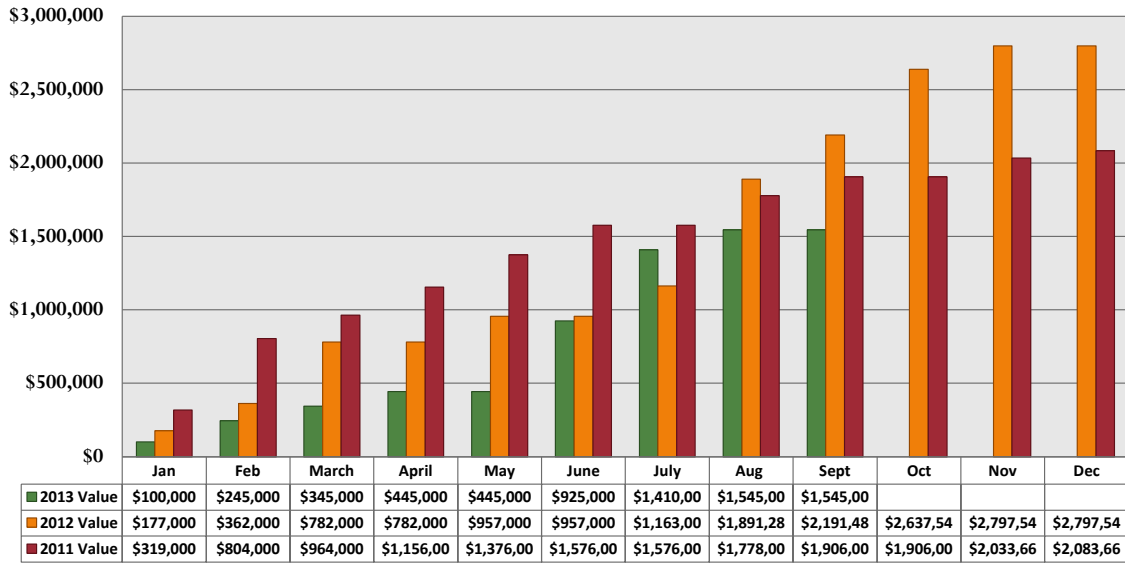

Cleburne Residential Permit Valuations YTD 2011 thru 2013

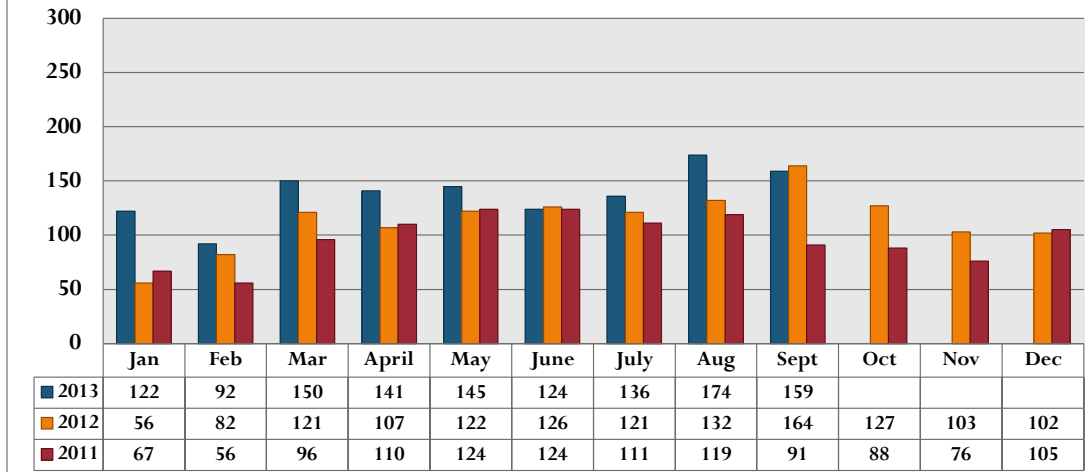
YTD Residential Valuations

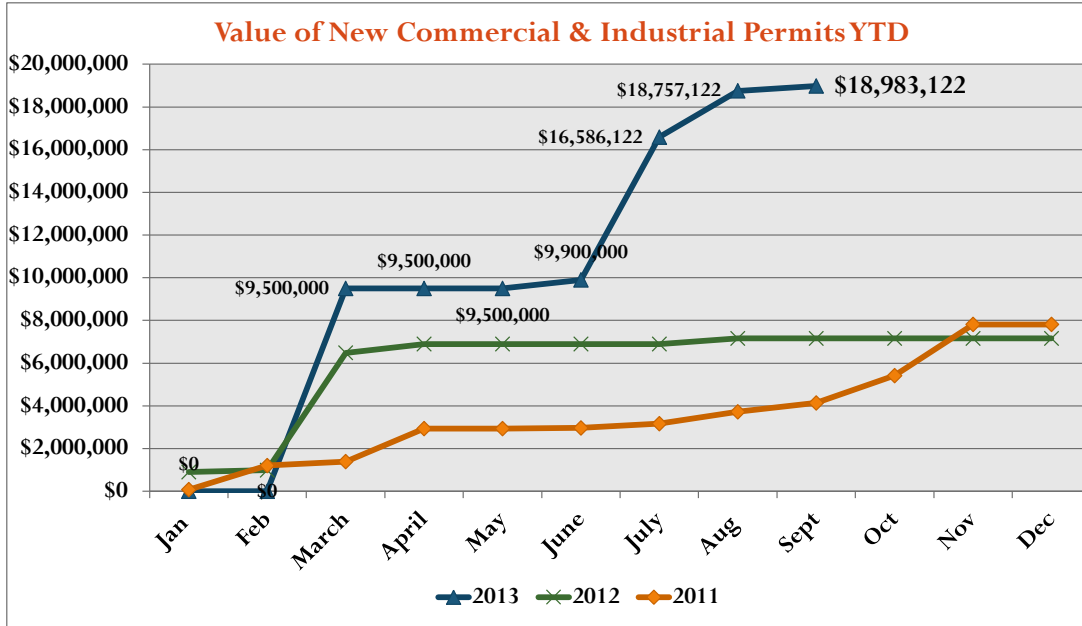
Johnson County Residential Sales 2011 thru 2013

Residential Units Sold**



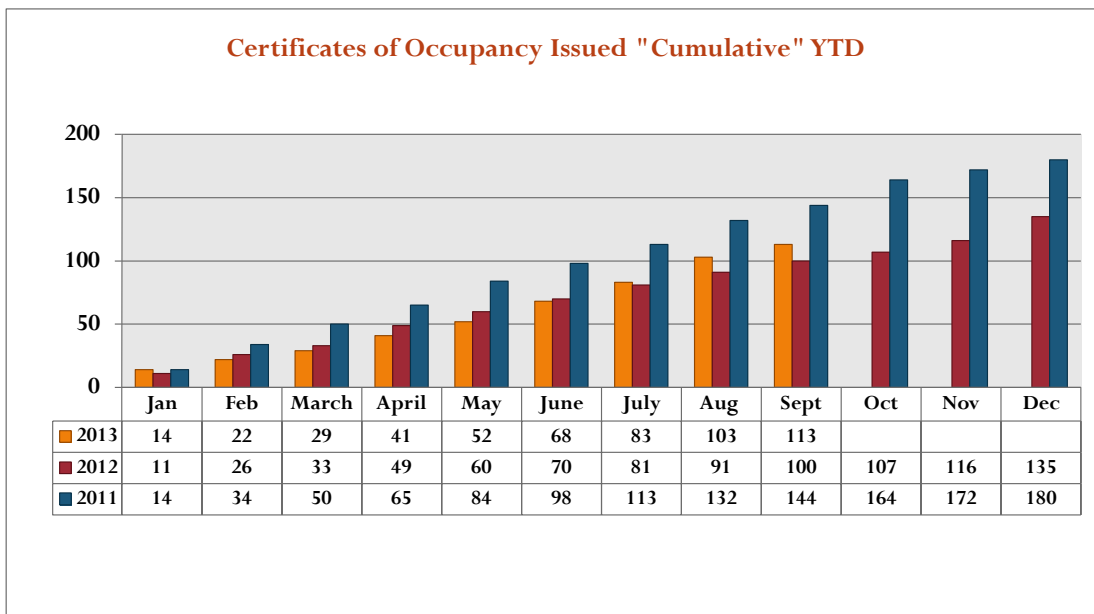

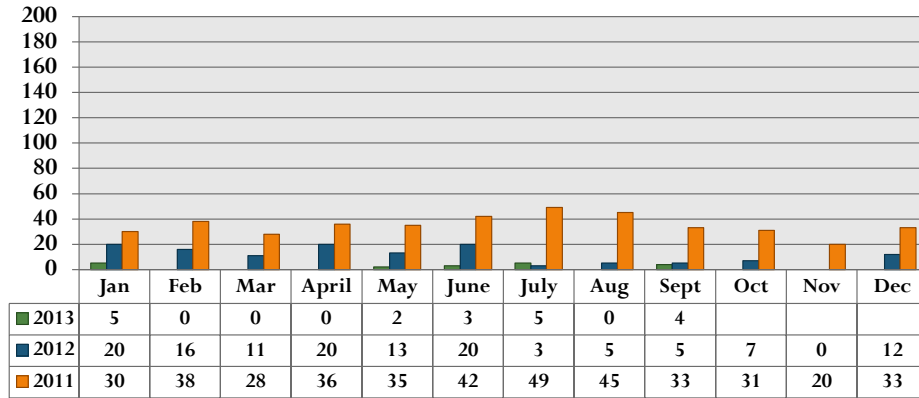
Cleburne Issued Certificates of Occupancy 2011 thru 2013

Drilling Permits Filed w/ RRC Johnson County 2011 thru 2013

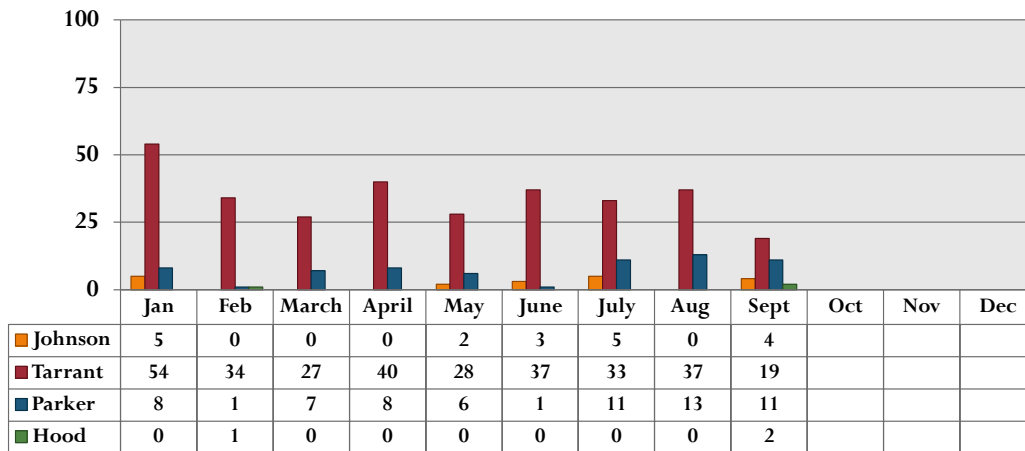
Monthly RRC Gas Drilling Permits Filed

Drilling Permits Filed for Johnson, Tarrant, Parker & Hood Counties for 2013

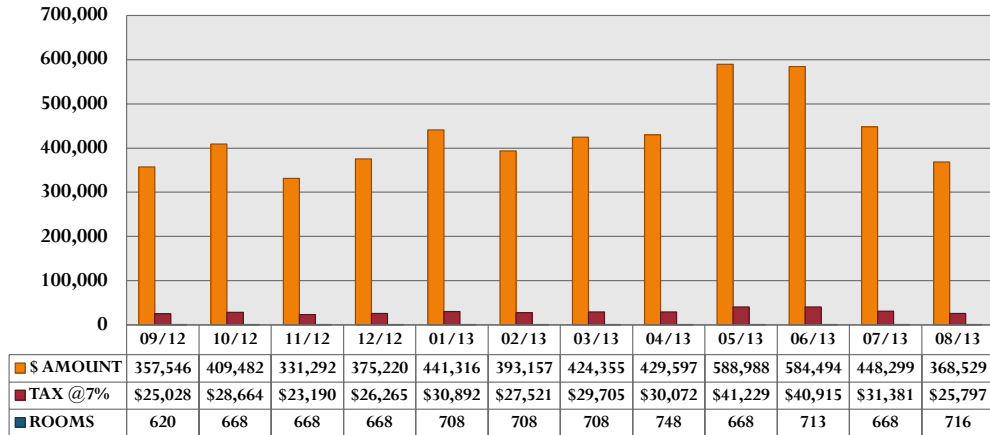

Cleburne Monthly Taxable Hotel Receipts

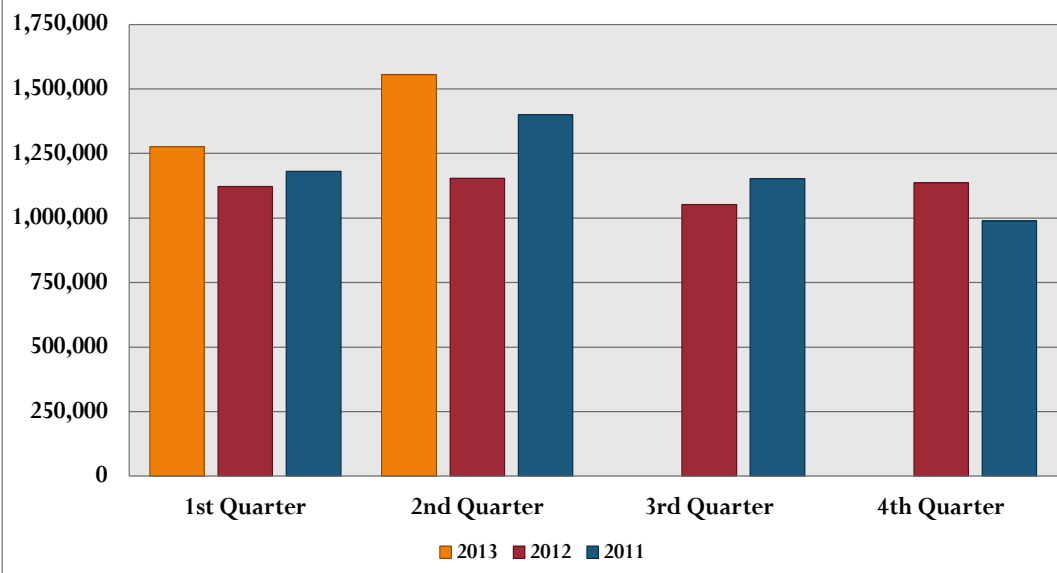
Monthly Taxable Hotel Receipts 12 Month's Ending



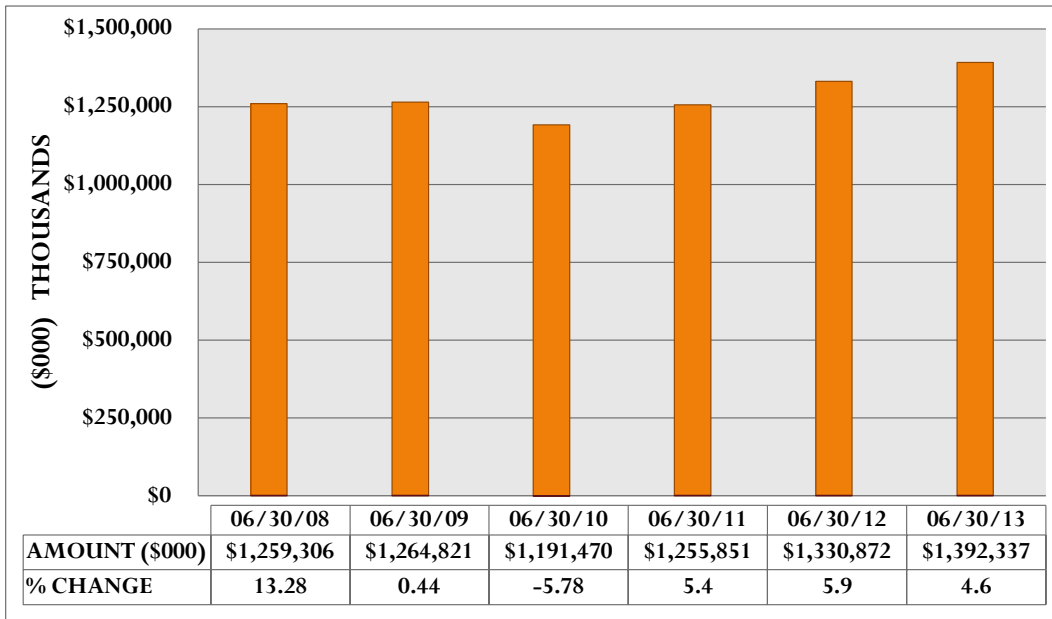

QUARTERLY HOTEL TAXABLE RECEIPTS



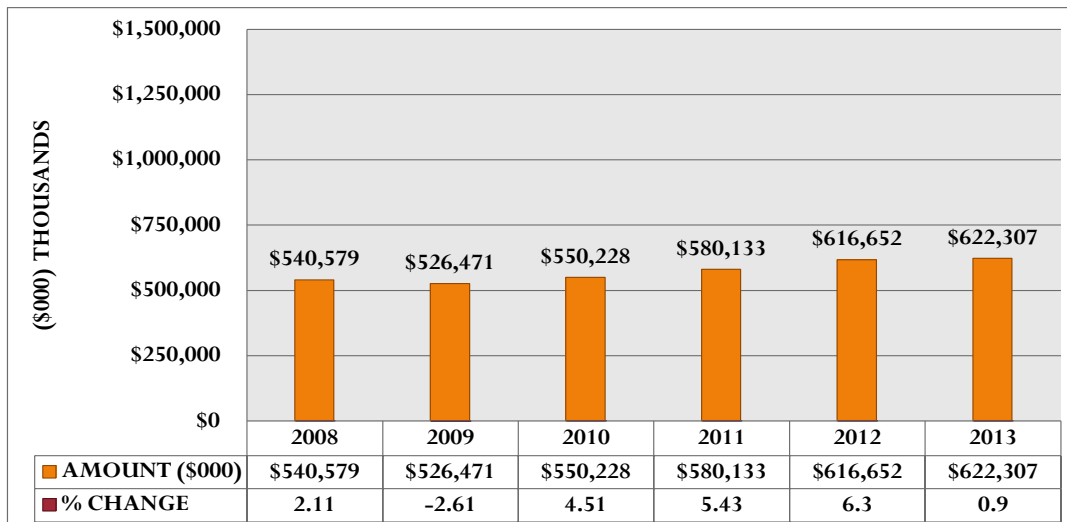

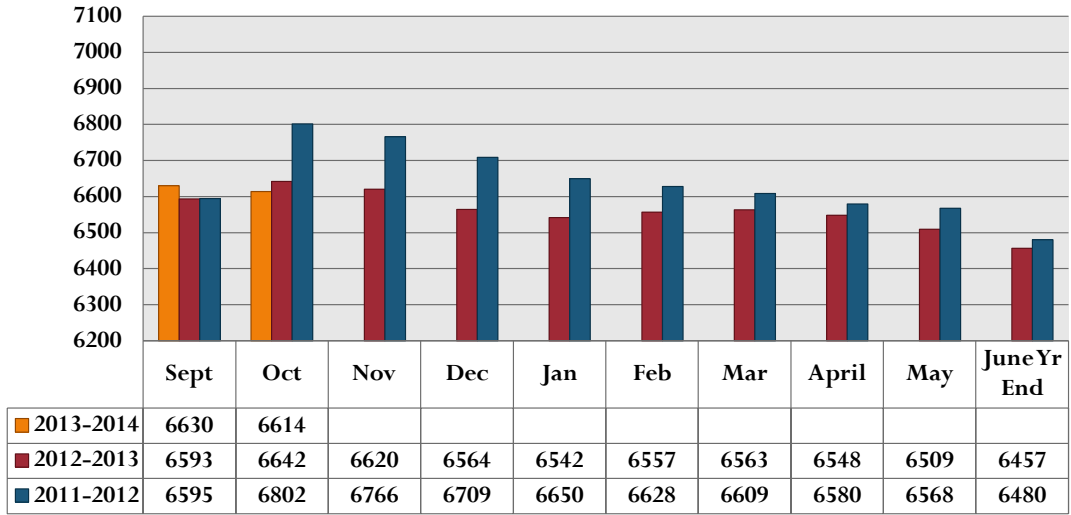
