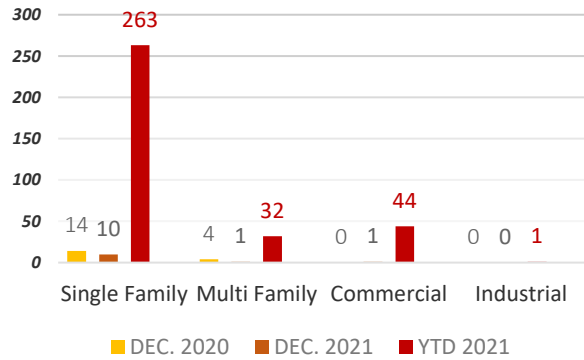

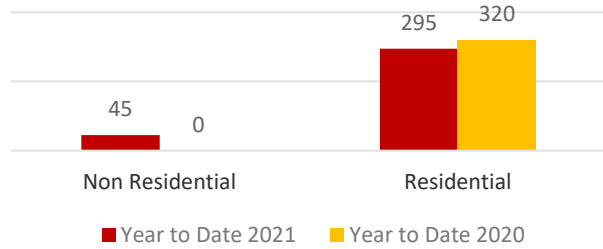

Building Permits Year-Over-Year

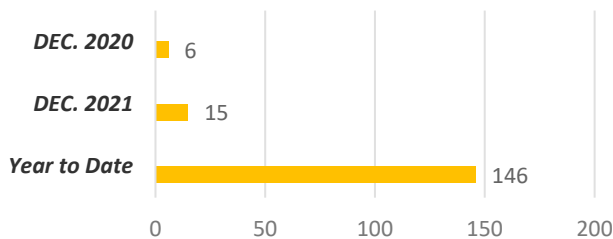

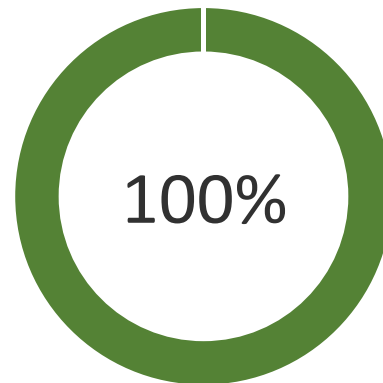
