### Splash Bash Renter's Agreement

We ensure Splash Station achieves its goals of providing clean, safe, and healthy facilities, and a positive reservation/check out experience. We have developed the following information on rules, terms and conditions for renting Splash Station facilities. **The renter is responsible for 1) ensuring that all guests (swimming or non-swimming) are aware of and comply with all rules and regulations of the facility, including but not limited to their admission into the park.** By signing the rental agreement, the renter states that the renter has read and agrees to abide by all conditions.

#### I. RENTAL PROCEDURES/POLICIES

- A. **RESERVATIONS:** The renter must be 18 years or older. The renter, not designee, is required to sign the application. All reservations must be made two weeks in advance. Any down-payment fees are due at the time of the reservation to ensure your requested date/time. Make all check/money orders payable to: **Splash Station.** Photo identification is required for payments by check. We also accept Visa, MasterCard, Discover for all payments.
- B. **APPLICATION APPROVAL:** Splash Station holds the right to deny any requests for good cause. An explanation will be given.
- C. **GENERAL INDEMNIFICATION:** The renter agrees to pay for all damages to any property of Splash Station resulting directly or indirectly from the conduct of any member, guest or invitee. The renter also agrees they will hold Splash Station harmless and indemnify Splash Station from and against any and all liability, damages, and/or injury which may be imposed upon for any injury to persons or property caused by the renter or any other person in connection with renter's use of the facility named in this agreement. Renter assumes any and all risk associated with the use of Splash Station facilities and equipment.
- D. **INTELLECTUAL PROPERTY APPROVAL AND INDEMNIFICATION:** The user must, at their own expense, obtain any necessary licenses and/or permits and comply with applicable federal, state and local laws, codes and regulations.
- E. **ADDITIONAL REQUIREMENTS:** Splash Station may require additional security to be hired at the expense of the renter. A list of chaperones may be required.
- F. **CANCELLATIONS:** Voluntary Cancellations must be submitted one week in advance or risk forfeiture of the down-payment. A limited refund may be given due to weather and/or water quality. All refunds are subject to manager approval. Refund process may take 2-3 weeks to be complete. Renter will be mailed a check from the City of Cleburne if approved by all departments.
- G. **ADMISSIONS:** This agreement is solely for the rental of the agreed time at the assigned area. Additional guests must pay the \$6 entry fee. All admission fees must be paid following rental at the Splash Station office with required guest list or upon entry to Splash Station.

#### II. RULES

All rules must be obeyed by the renter and any member, guest or invitee specified in the rental agreement. Failure to adhere to the rules and/or this agreement shall be considered a breach of contract and shall be penalized as prescribed below.

- A. Any violation of the following or the facility rules may result in: 1) Immediate termination of rental 2) Forfeiture of fees, 3) Disqualification from future rentals, and if necessary, 4) Police will be called. In addition any repeated and/or uncorrected Minor Violation may also be considered a Major Violation.
  - 1. Facility staff **MUST** be respected and obeyed.
  - 2. All persons and activities must comply with City, State, and Federal laws. This includes the prohibition of use and/or possession of weapons, liquor, tobacco products, and any illegal substances on the property.
  - 3. Children under 12 years of age must be supervised at all times by a person 16 or older. A child under 48 inches must be with an adult (16 or older) in the water within arms reach.
  - 4. The use of open flames, "silly string", confetti, and fog machines are prohibited. Candles for cakes are allowed. Coolers & outside food/drink are not permitted. Decorations belong to Splash Station and must not be removed from area or damaged. Renter may be charged for damage/missing decorations.
