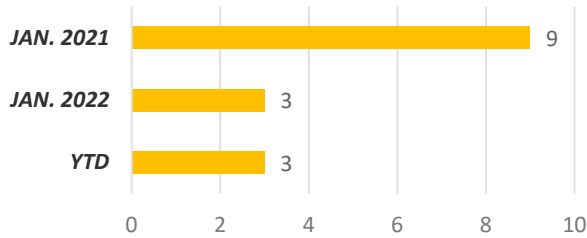

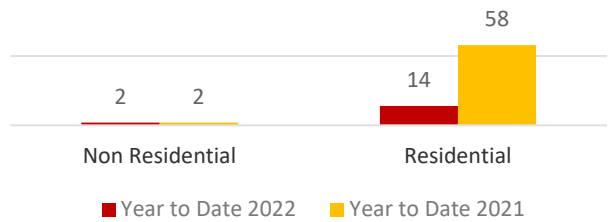

## New Construction Permits Year-Over-Year

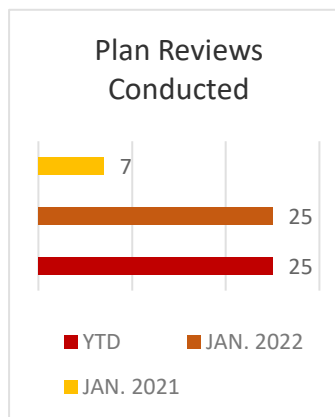
